Room Rates/Taxes:

Ground transportation from all airports to Montelucia is available via limousine, shuttle van, bus charter, taxi, sedan service and/or car rental. 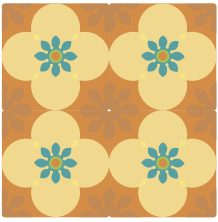
Cancellations/Refunds
