To make your sleeping room reservations early for the *AHCA/NCAL 2010 Spring Multifacility Conference for CEOs and Senior Executive Leaders*, call the Sandpearl Resort at 877-726-3111 or 727-674-4114 by **Tuesday, March 23, 2010**.

Room Rates/Taxes:

Take advantage of the special group rate of \$229.00 per night, single or double occupancy plus appropriate tax and service charges. This rate does not include a \$15.00 resort amenity fee per room per night. The resort fee includes: access to the resort's state of the art golf front Fitness Center; unlimited local calls and tool free numbers; wired and wireless internet access for guest room and public space, delivered daily newspaper, in room coffee and bottled water, nightly shoe shine, access to the Business Center, and beach/pool towels. The rate will be extended for two days

prior to and after the conference dates based on hotel availability.

Reservations can be guaranteed by providing a first night's deposit or a major credit card. Transportation and Destination Information

Sandpearl Resort is conveniently located near Tampa International Airport (TPA- Tampa Bay, FL; approximately 40 minutes by car) or St. Petersburg/Clearwater Airport (PIE–Clearwater, FL; approximately 25 minutes by car).
