

## Connecticut

The proposed \$1.05 billion reduction in Medicare Part A skilled nursing facility expenditures on a nationwide level has a substantial impact on the local, state, and national economies. The estimated economic impact for Connecticut is a reduction of \$42,197,193 in business activity, a reduction of \$22,053,070 in labor income, and a loss of 528 jobs.

The following schedule illustrates the direct, indirect, and induced impact of this cut in reimbursement on the state of Connecticut.
