

Maryland

The proposed \$1.05 billion reduction in Medicare Part A skilled nursing facility expenditures on a nationwide level has a substantial impact on the local, state, and national economies. The estimated economic impact for Maryland is a reduction of \$37,950,667 in business activity, a reduction of \$19,239,158 in labor income, and a loss of 531 jobs.
