GS Strategy Group conducted an online survey on behalf of the American Health Care Association and National Center for Assisted Living (AHCA/NCAL) from May 6-9, 2020 among 1,500 registered voters throughout the United States. Below are some key findings from that research.


## **TOP TAKEAWAYS:**

- A vast majority of voters believe long term care facilities need more support from the government and the lack of support thus far has negatively impacted their ability to protect seniors.
- Overwhelmingly, voters want the government to provide long term care facilities with the same resources as
  hospitals including over 80 percent of those over 65 years old supporting an additional \$10 billion in funding for
  long term care facilities to provide additional PPE, staff, and testing to residents.

## **KEY FINDINGS:**


By a three-to-one margin, voters say that nursing homes and assisted living communities need more money for PPE, staff, and increased testing capabilities.

Generally speaking, would you say that nursing homes and assisted living communities have enough resources to respond to the threat that coronavirus presents to the seniors that they serve, or do they need more money to pay for personal protective equipment (PPE), tests for coronavirus, and more staff?




72 percent of voters agree that a lack of government funding has had a negative impact on the quality of care that residents of these facilities are receiving.

Do you agree or disagree that a lack of government funding for nursing home care has had a negative impact on the quality of care seniors have received during the coronavirus?



Overwhelmingly, voters want the government to provide long term care facilities with the same resources as hospitals.

Agree or Disagree: The government should provide resources to nursing homes and long-term care facilities just as it does to hospitals.



As a result, more than three-quarters of voters (including over 80 percent of those over 65 years old) support an additional \$10 billion in funding for long term care facilities to provide additional PPE, staff, and testing to residents.

Nearly half of respondents strongly supported the additional \$10 billion in funding.
