Key Dates

Note the following key dates to stay on track:

- July 2025 - Application Launch
- August 2025 - Quality Award Portal Opens
- ★ **November 13, 2025 - Intent to Apply Deadline**
- ★ **January 22, 2026 - Application Deadline**
- Summer 2026 - Silver Notifications

AUGUST

SEPTEMBER

OCTOBER



Using the [Silver Criteria Series](#), complete your responses to Category 4-5 and prepare the results for these categories.

- Submit your application and payment in the Quality Award Portal.

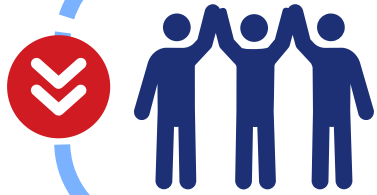

Post-Application Submission



FEBRUARY 2026

Congratulate your team on completing the Silver application! Plan to discuss any opportunities for improvement identified while completing the application.



SUMMER 2026

Award notifications and feedback reports are distributed.

- If you received the award, plan promotional activities and consider the next steps in your Quality Award journey.
 - Ensure you stay up to date on Recipient next steps.
- If you were not recommended for an award, review your feedback report to understand where the criteria was not met. Develop a plan to address these areas and to resubmit your Silver application in 2027.



FEEDBACK REPORTS

Review your Feedback Report, paying close attention to the executive summary, action steps, strengths, and opportunities for improvement to develop an action plan and determine the next steps in your quality improvement and Quality Award journey.



OCTOBER 2026

Attend Delivering Solutions 26, the AHCA/NCAL Convention & Expo and the Elevating Excellence Award Ceremony in October 2026.
