ORGANIZATIONAL SUCCESS

Staff Stability

- **Goal:** Decrease turnover rates among nursing staff (RN, LPN/LVN, CNA/LNA) by 15% or achieve/maintain at or less than 40% by March 2018
- **Progress:** As of February 2017*, 6.4% of members have achieved a nursing turnover rate at or below 40%. For more information, click [here](#).

Customer Satisfaction

- **Goal:** At least 25% of members will measure and report long-stay resident and family satisfaction and/or short-stay satisfaction using the Core-Q survey by March 2018

SHORT-STAY/POST-ACUTE CARE

Hospital Readmissions

- **Goal:** Safely reduce the number of hospital readmissions within 30 days during a skilled nursing center stay by an additional 15% or achieve and maintain a low rate of 10% by March 2018.
- **Progress:** As of September 2016*, 20.8% of members centers have achieved a 30% reduction in hospital readmissions or achieved a rehospitalization rate below 10%. For more information and resources, click [here](#).
 - Since January 2012 AHCA members have prevented over 79,000 all-payer readmissions and saved over \$820 million.
 - Unlike the readmissions measure on Nursing Home Compare, which only includes Medicare Fee-For-Service (FFS), the PointRight® Pro 30™ measure AHCA uses to track progress includes everyone admitted to a SNF regardless of payer.

Discharge Back to the Community

- **Goal:** Improve discharge back to the community by 10% or achieve and maintain a high rate of at least 70% by March 2018.
- **Progress:** As of June 2016*, 36.6% of AHCA members have improved their baseline rate by 10% or achieved a 70% rate of safe discharges back to the community. For more information and resources, click [here](#).
 - Unlike the discharge to community measure on Nursing Home Compare, which includes only Medicare Fee-For-Service (FFS), AHCA's safe discharge to community measure for tracking progress includes everyone admitted to a SNF regardless of payer.

LONG-TERM/DEMENTIA CARE

Antipsychotics

- **Goal:** Safely reduce the off label use of antipsychotics in long-stay nursing center residents by a total of 30% by December 2016.
- **Progress:** Based on CMS data, as of October 2016*, 54.2% of AHCA members have achieved the goal of a 30% reduction. For more information and resources, click [here](#).
 - 15.5% of long-stay residents in AHCA member centers were given antipsychotics at some point during Q4 2016*.
 - AHCA members' average rate has decreased by 34.3%* from Q4 2011, which saw a 23.6% off-label use of antipsychotics.
